LETTER *from the* BOARD

Friend,

Every year, the effort to safeguard the Boundary Waters Canoe Area Wilderness shifts - political winds gust one way or another, and we adapt our strategies to meet the moment. Northeastern Minnesotans for Wilderness (NMW) formed the effort known as the Campaign to Save the Boundary Waters ten years ago to permanently protect the Boundary Waters from the threat of sulfide-ore copper mining, leaning into the winds of change, whether they are at our backs or coming at us headstrong.

Today, a strong wind is at our back. 2022 proved to be a momentous year for the Boundary Waters and culminated in an intensive push for permanent protection legislation in our nation's capital. Although we did not see the bill become law this time around, the work our team put in day in and day out, both in D.C. and at home, has put us in a strong position to continue to advocate for this critical legislation. We are so grateful to our partners and supporters for everything they have done to support this effort.

The movement remains strong, in large part due to the willingness of individuals like you to speak loudly for the Boundary Waters. The impact of grassroots participation was clearly demonstrated in January of 2022, when we organized partners and the public to submit over 250,000 comments supporting the 20-year ban to the U.S. Forest Service during a 90-day comment period. This huge number of comments eclipsed the 181,000 comment mark from a prior federal application in 2017.

After last year and the many previous years of engaging with our federal agencies through a robust process of public comment periods, hearings, and a long anticipated, comprehensive review of the facts, this year the Boundary Waters received a critical milestone for the protections it deserves. **On January 26, 2023, U.S. Interior Secretary Deb Haaland issued a Public Land Order protecting federal lands in the Boundary Waters watershed from mining for 20 years. We and the Boundary Waters community at large owe a great debt to Secretary Haaland and to the Biden Administration for listening to the will of the people, for their deep analysis of the science, and for making this decision to protect America's most popular Wilderness.**

While we celebrate this enormous accomplishment, the work is not finished. The Boundary Waters is not a temporary wilderness. As the impacts of climate change loom large, and the importance of land conservation for our nation's mental, physical, and environmental health is realized, the obvious becomes even more clear: The Boundary Waters is not a landscape that deserves any less than protection for generations to come.

We are in this for the long haul, and we hope you are too. 2023 has already proved a historic year for canoe country. The wind at our backs will help us against fierce opponents, who downplay the science and prioritize short term profits for the benefit of a foreign mining conglomerate. We have seen these winds before, and know them well - we also know that together, we can keep moving forward despite them.

Critical to our efforts to protect the Boundary Waters is knowing that it is for everyone. This landscape is not "untouched," but in fact has been stewarded for thousands of years by people who lived here under its dark skies, paddled its waters, and explored its forests. We enthusiastically partner with the many organizations and camps in our region that focus on access to outdoor experiences for youth, people of color, the LGBTQ community, people with disabilities, and more. Engaging people across differences means a greater and stronger conservation movement of people working to protect and enjoy this place forever.

Time and time again, you heed our call for action and speak loudly for this quiet place. Thank you for everything you have done in the effort to protect our one of a kind canoe country.

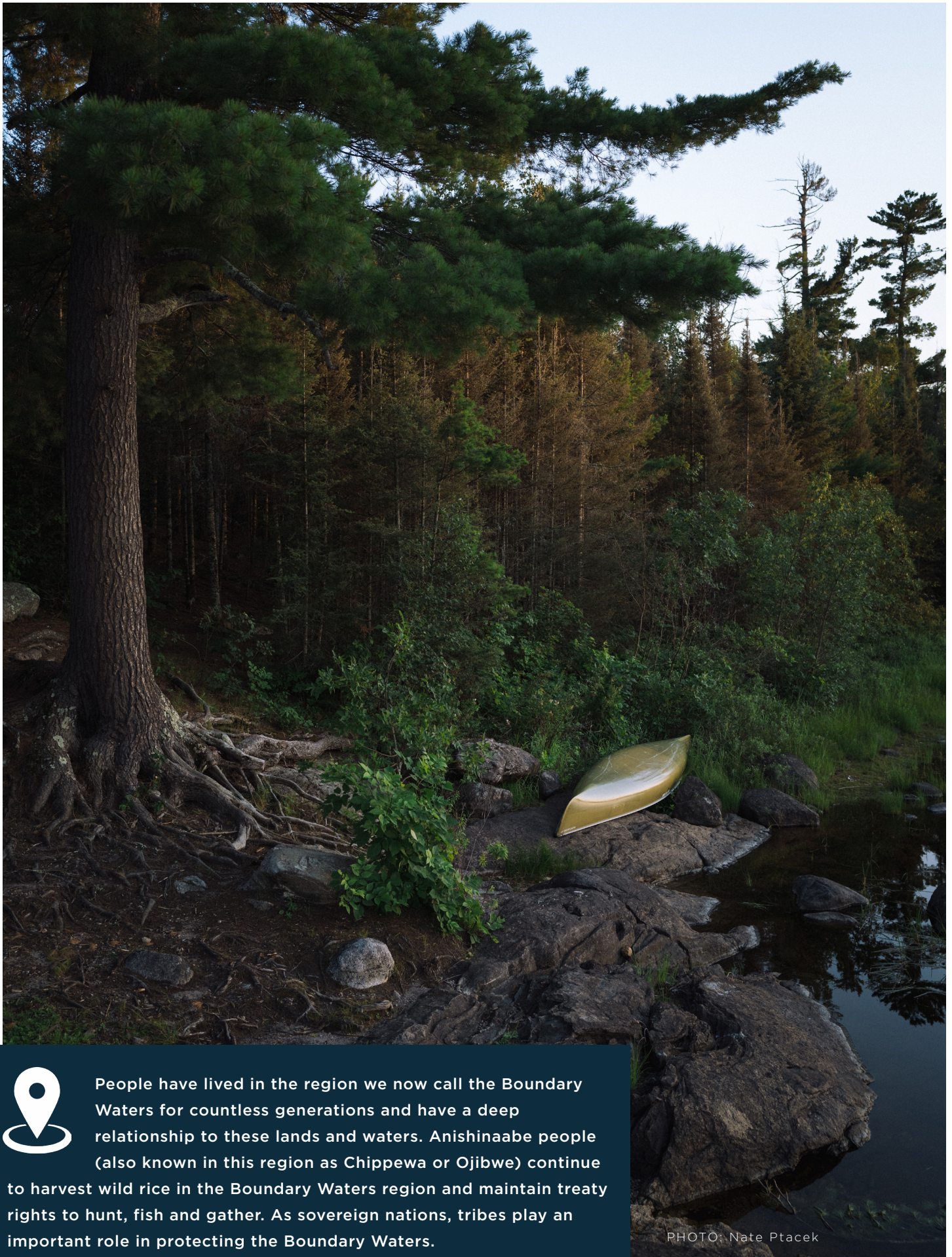

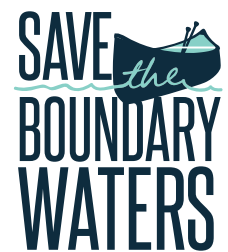

We are a locally-based national wilderness and public lands advocacy group that unites people to protect the Boundary Waters and greater Quetico-Superior region. Our flagship program for the last 10 years, and what most people know us by, is Save The Boundary Waters. The Campaign to Save the Boundary Waters is our national coalition of more than 400 businesses, conservation, and hunting and angling groups united to permanently protect the wilderness from copper mining.



NORTHEASTERN MINNESOTANS FOR WILDERNESS

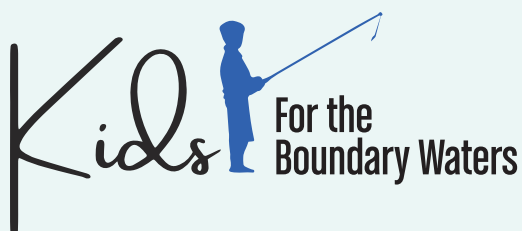
MISSION: We unite people to advocate for the protection of wilderness and wild places, especially the Boundary Waters Canoe Area Wilderness and the greater Quetico-Superior Ecosystem.

VISION: We envision a future where people understand the value of wild protected lands, and are unified to forever protect the greater Boundary Waters Wilderness and the greater Quetico-Superior Ecosystem as vital components of a healthy and resilient planet.

Our alliance of 375 small businesses, manufacturing companies, outdoor retailers, hunting and fishing businesses and others that rely on and support this world-class wilderness for employment and quality of life.



We coordinate this impressive youth-founded and led group that has taken hundreds of kids on advocacy trips to Washington D.C. to meet with decision makers. 40 young people went to D.C. in June 2022. A member of Congress even called Kids for the Boundary Waters the most impactful lobbying group coming to D.C!

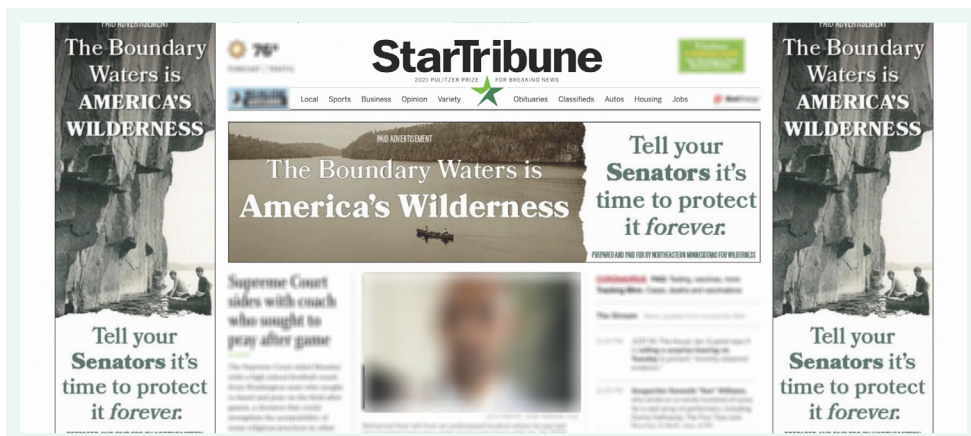
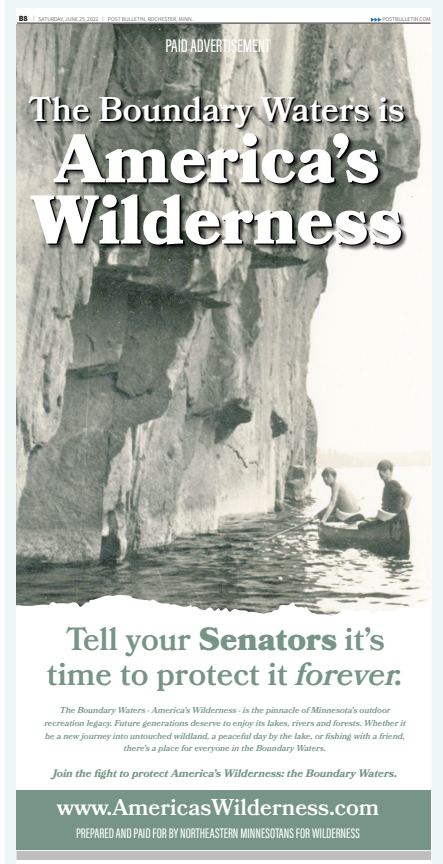

Our Ely-area community and economic development program is grounded in our local roots and values of sustainability and prosperity. We coordinate the popular weekly Tuesday Group forum. In 2022, nearly 1900 people attended a total of 46 Tuesday Group presentations, including four editions of our Meet New Elyites segment. We developed a formal collaboration with Northern Grounds to sustain Society Hall Workspace in 2022, and over 500 people used this coworking space on the edge of the Wilderness. We established a set of Hello Neighbor programs and services designed to serve a new resident recruitment and retention for regional economic growth.

AMERICA'S WILDERNESS

America's Wilderness is our creative media campaign launched in 2022 to drive home the importance of protecting this beloved, timeless, wilderness for all. Our ads on transit, newspapers, billboards, and more garnered an estimated **9.1 million impressions** in 2022.



OUR MULTI-PRONGED APPROACH

The Campaign to Save the Boundary Waters is unique in its efforts to help outdoor enthusiasts protect America's most visited Wilderness, the BWCAW. We advocate for the Boundary Waters on behalf of supporters around the world by implementing a multi-pronged protection approach.

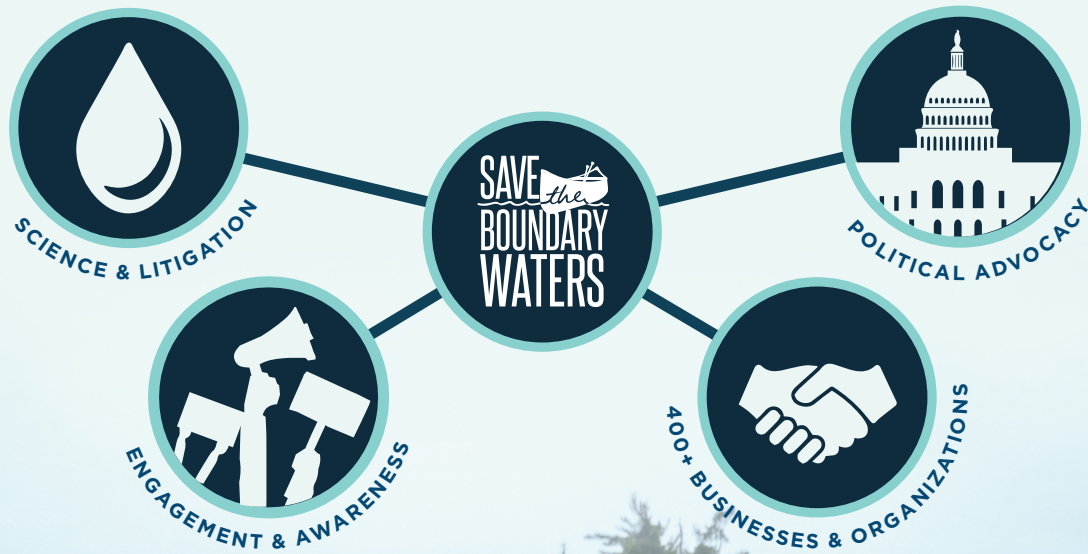

BROAD COALITION

We cultivate and lead a powerful and far-reaching movement to defend the Boundary Waters. Our Campaign includes 400+ businesses, conservation, and hunting & angling organizations, and millions of adventurers, advocates, conservation experts, outdoor brands, Indigenous people (including those that hold Treaty Rights in this region), camps and access programs, creatives, elected officials, and more.



SCIENCE

In 2022, **our policy & science staff completed a third year of water quality monitoring in the Birch Lake area of the Boundary Waters watershed.** Our monitoring program manager, Lisa Pugh, was trained in state and federal quality assurance protocols by state agency staff and Ph.D. water quality scientists and professors, **enabling us to produce professional-quality data.** The quantity of our collections in the Birch Lake area exceeds that collected by the State of Minnesota. Our monitoring work has been accepted as an Minnesota Pollution Control Agency-recognized project, giving us access to upload data directly to the MPCA's database. Your donations and grants entirely support this crucial water quality monitoring work.

During the environmental assessment of the proposed 20-year mining ban, our team wrote and submitted to the federal agencies a highly researched, comprehensive 312-page document of technical comments, making the scientific and legal case for protection. Thank you to our partners who joined us in this comment letter: Center for Biological Diversity, Earthjustice, National Parks Conservation Association, The Wilderness Society, Wilderness Watch, and Voyageurs Conservancy.

AWARENESS

In 2022, the Campaign to Save the Boundary Waters saw immense engagement via our digital and print pieces. We **reached over 13.1 million people** from across the United States through advertising, social media, digital media, emails, and other communications channels. In 2022 alone, over **121,000 people took action** in support of protecting the Boundary Waters, and just under half of those were brand-new supporters (60,000 people!) In addition, we received prominent news coverage in The Washington Post, Reuters, Bloomberg, The Star Tribune, Minnesota Public Radio, The Wall Street Journal, The New York Times, REI Uncommon Path, and more.

ENGAGEMENT

In 2022, our grassroots team worked with many volunteers, local businesses, and thousands of activists to host and attend dozens of events, connecting with communities across Minnesota and the Midwest, from Fargo to Chicago.

In total, our staff and volunteers hosted 24 unique events, tabled at partner businesses 23 times, participated in 11 festivals, fairs, or expos, held 8 webinars, presented to the staff of 7 youth group organizations and wilderness schools, gave 16 presentations to Leadership Development Program participants and general campers at YMCA Camps Du Nord and Northern Lights, presented 12 times to groups visiting our Ely Headquarters, and engaged with people from across the country with 45 different texting campaigns! Our phenomenal volunteers assisted us in engaging with people across the country, and our business supporters enabled us to host these exceptional events.

POLITICAL & LEGAL ADVOCACY

We met regularly with decision-makers at all levels of government. In 2022 alone, we held 300 meetings in Washington, bringing 81 people from across the country to meet members of Congress. We also provided leadership and tools to get citizens, businesses, and other organizations advocating for the Boundary Waters.

In 2022 we continued our litigation on the state and federal levels, including our first-of-its-kind environmental lawsuit challenging Minnesota's mine siting rules, and our defense of the cancellation of federal mining leases previously held by Twin Metals. *See more on page 15.*

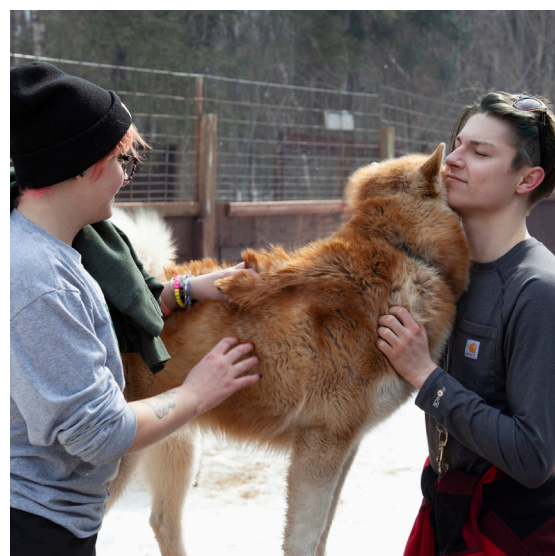

OUR SIGNIFICANT WINS:

TWIN METALS LEASES CANCELED

On January 26, 2022, the Biden administration announced that it canceled two unlawfully renewed mineral leases for sulfide-ore copper mining next to the Boundary Waters. The Department of Interior determined that the expired Twin Metals leases were unlawfully renewed by the prior administration.

REJECTION OF TWIN METALS' MINE PLAN

In December 2021, the U.S. Bureau of Land Management rejected Twin Metals' mine plan. In February, the Minnesota Department of Natural Resources ended consideration of the Twin Metals mine plan citing the loss of federal leases and concerns about Twin Metals' plan to store hundreds of millions of tons of toxic waste on state school trust lands.

ON THE GROUND IN WASHINGTON, DC

We made major progress on Rep. Betty McCollum's bill - The Boundary Waters Protection and Pollution Prevention Act. Our team put in an incredible effort attempting to get the bill included in Congress' year-end package. Though we didn't achieve our most ambitious goal this time, our diligent work smooths the path for this important national bill in the future. Rep. McCollum has introduced the bill again in 2023.

In 2022 alone, we had over 300 meetings in DC, bringing 81 people from across the country to meet with elected officials, including U.S. House and Senate offices. In June, the Kids for the Boundary Waters made their first trip back to Washington, D.C., since 2019! We had 40 kids from 10 states tell their stories and meet with lawmakers supporting Rep. Betty McCollum's bill.

LAWSUIT

On December 22, 2022, we, along with ten area businesses and four other conservation groups, moved to intervene on the side of the federal government against a Twin Metals lawsuit that seeks to force the renewal of terminated leases next to the Boundary Waters Wilderness. In this case, we are represented by Morrison & Foerster LLP.

- Jan. 19, 2022: Record-breaking **250,000 public comments submitted** supporting ban on copper mining near the Boundary Waters
- Jan. 24, 2022: U.S. Forest Service confirmed its 2016 decision to withhold consent to the renewal of Twin Metals mineral leases remains in effect
- Jan. 25, 2022: U.S. Department of Interior issues legal memorandum finding that the Twin Metals mineral leases were unlawfully renewed in 2019
- Jan. 26, 2022: **Twin Metals mineral leases canceled** by the Department of Interior
- Feb. 18, 2022: The Minnesota Department of Natural Resources **ended consideration of the Twin Metals mine plan**
- May 24, 2022: Congressional Hearing on Rep. McCollum's bill HR 2794
- June 23, 2022: **Forest Service Draft Environmental Assessment released** - finds major risk to Boundary Waters from sulfide-ore copper mining
- July 13, 2022: **HR 2794 - Boundary Waters protection bill advances out of key Congressional committee**
- Aug. 12, 2022: More than 80,000 additional signatures submitted in support of the Forest Service's proposed 20-year mining ban
- Dec. 22, 2022: We filed to intervene in Twin Metals lawsuit
- Jan. 23, 2023: **20 year mining ban** - Interior Secretary Deb Haaland signed a Public Land Order protecting the Boundary Waters from sulfide-ore copper mining

WHAT IS NEXT FOR PERMANENT PROTECTION?

20 YEAR MINING BAN

In January, U.S. Secretary of the Interior Deb Haaland issued a **20-year mining ban on federal public lands around the Wilderness!**

This is the most significant achievement for Boundary Waters protection *since 1978*. This is a huge victory, but the Boundary Waters is not a 20-year Wilderness. It is a forever wilderness and needs lasting, permanent protection on both federal and state lands.

In January 2023, U.S. Representative Betty McCollum reintroduced legislation in the U.S. House of Representatives to protect the Boundary Waters by permanently banning sulfide-ore copper mining from within the watershed of the Boundary Waters and Voyageurs National Park. H.R. 668 or the Boundary Waters Wilderness Protection and Pollution Prevention Act.

U.S. Representative Pete Stauber and anti-Boundary Waters forces have pledged to challenge the Biden Administration's efforts to protect this Wilderness.

STATE

In early January 2023 at the Minnesota Capitol, the Boundary Waters Permanent Protection Bill was reintroduced in both the Minnesota House and Senate by chief authors Senator Kelly Morrison and Representative Sandra Feist. The bill bans sulfide-ore copper mining on state lands within the headwaters of the Boundary Waters Canoe Area Wilderness.

We brought a lawsuit challenging the Minnesota's non-ferrous mining rules, filed pursuant to the Minnesota Environmental Rights Act (MERA) on June 24, 2020. We allege that the current mining rules - adopted 30 years ago - fail to protect the Boundary Waters and its watershed. The Minnesota Department of Natural Resources must render its decision on or before May 31, 2023, as to whether Minnesota's current non-ferrous mining rules are adequate to protect the Boundary Waters. We are represented by Ciresi Conlin LLP.

"But there's still work to do. Permanent protection still must be implemented to prevent future chicanery from undoing BWCA protections or letting them expire. Legislation authored by U.S. Rep. Betty McCollum, D-Minn., would do that and merits swift passage. State lawmakers also must pass Sen. Kelly Morrison's bill to put mining restrictions on state land in the BWCA watershed."

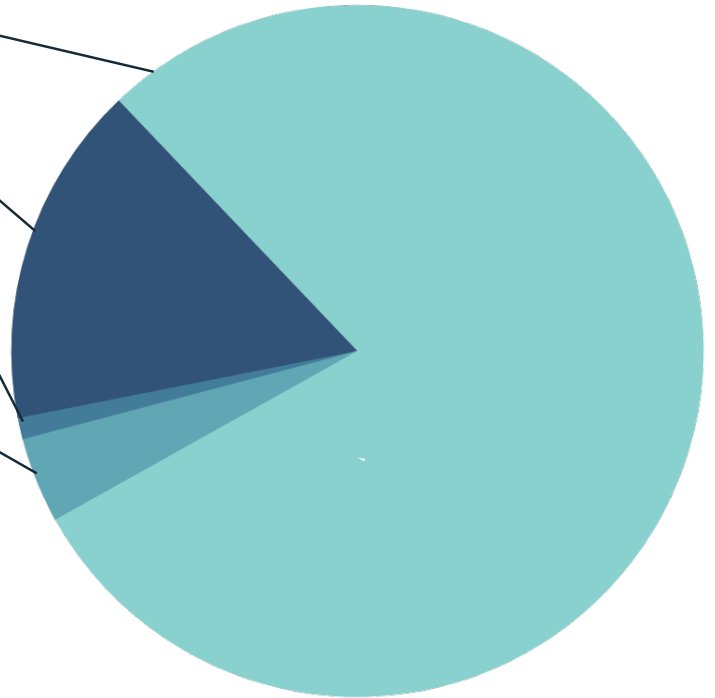

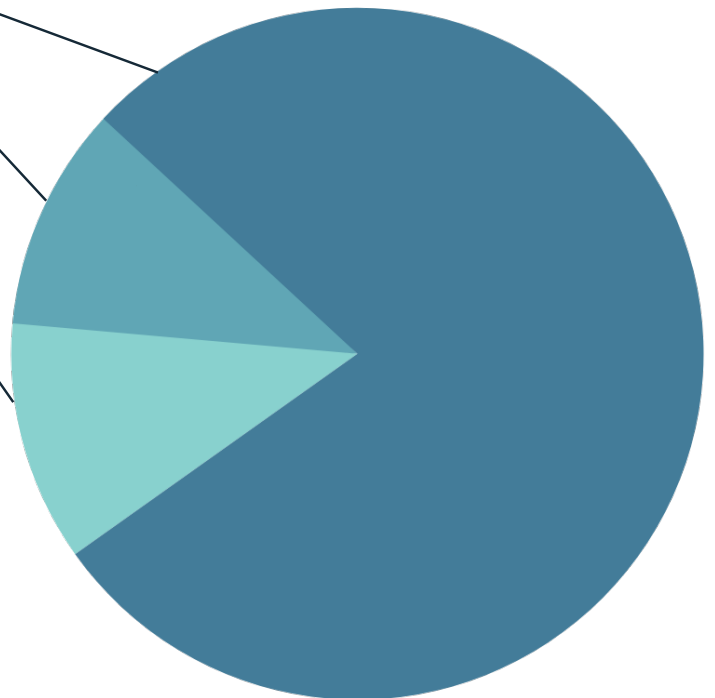

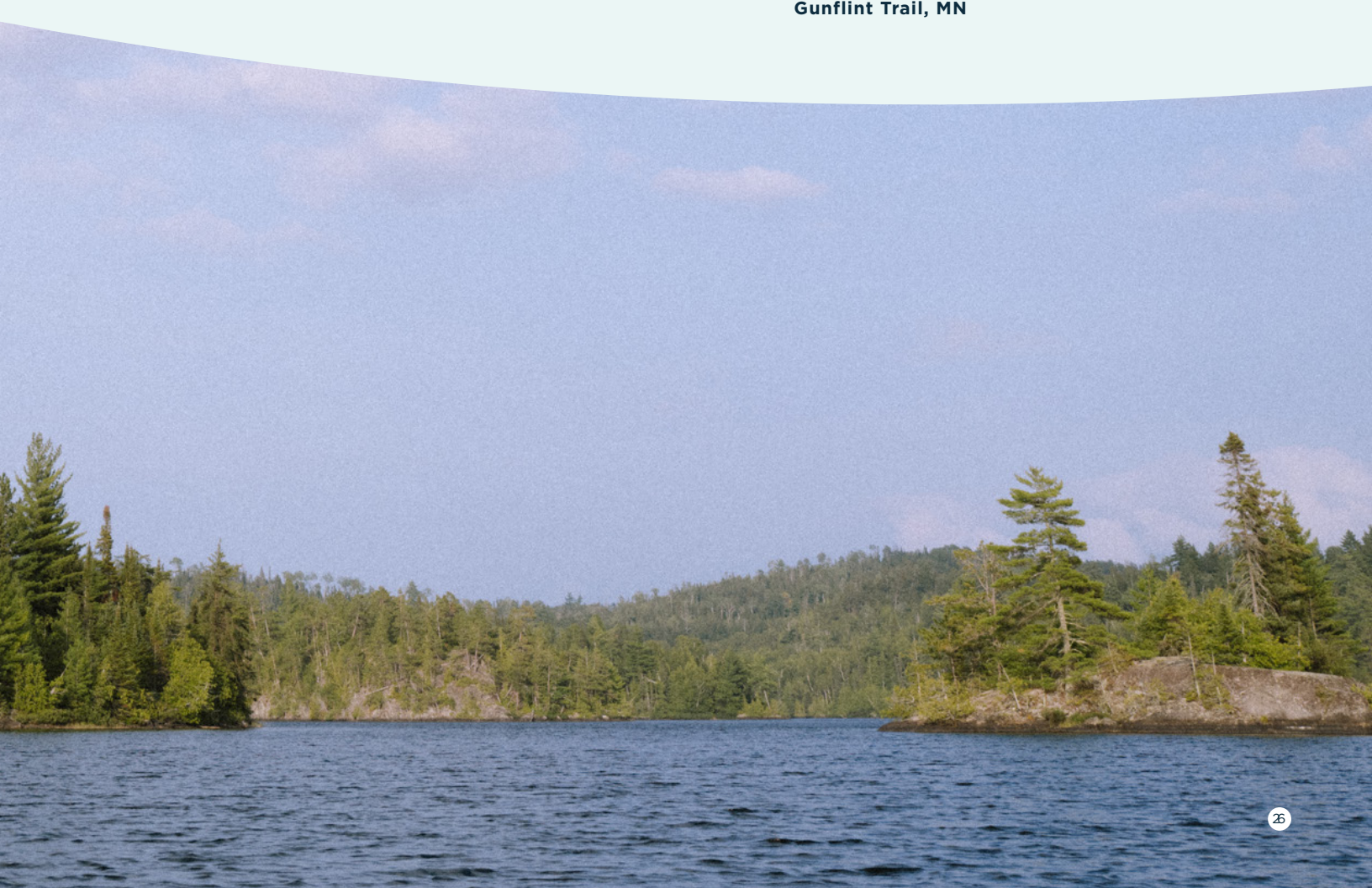

ENVIRONMENT & CLIMATE

A protected Boundary Waters is essential for mitigating the impacts of climate change on a global scale. The Boundary Waters and its greater 4.3-million-acre wild ecosystem is one of the six most important regions in the lower 48 states critically necessary for adaptation, resilience, and biodiversity.
